
## Trends and Observations

### Introduction

“The real heroes of the digital revolution in higher education are librarians; they are the people who have seen the farthest, done the most, accepted the hardest challenges, and demonstrated most clearly the benefits of digital information.... It is a testimony to their success that we take their achievement for granted.”<sup>1</sup> This recent endorsement by senior university administrators is a perceptive observation. Indicators of the digital revolution in research libraries can be seen in the annual *CARL Statistics*: rapid expansion of access to electronic journals, more options for document delivery, easier access to data archives, new services.

Expanded access to electronic journals is the most dramatic evidence of the digital revolution in research libraries. The number of electronic serial titles accessible in member libraries rose by 41% from the previous year and more than doubled in two years.

Even this increase does not reveal the deepening availability of online journal backfiles and the enhanced links among online indexes and journals that are expanding the scope and convenience of access to electronic journals. Usage data on the Canadian Research Knowledge Network web site ([www.researchknowledge.ca](http://www.researchknowledge.ca)) documents that more intense use of electronic resources is a reality, not just a potential.

In research libraries as in other organizations, planning and outcomes are linked through a chain of expectations--from inputs to activities to outputs to outcomes. The annual *CARL Statistics* provide information about inputs, activities and outputs. This national data, collected over many years, is an important source for monitoring Canadian research libraries, for observing trends and for suggesting issues which need further exploration. Other methods and resources are necessary to document the impact of research library collections and services and of the collaborative arrangements which are creating an effective national resource.

Careful readers of the *CARL Statistics* need to remember that, in spite of attention to corrections and clarity, there are limitations in the data. Definitions may vary, either over time or as interpreted by an individual institution. The reliability and accuracy of data collection and reporting methods may be inconsistent. Every year there are some data elements that are not reported by all libraries. Thus, conclusions or comparisons--whether between institutions or over time-- should be made with caution, with knowledge of context and, preferably, in conjunction with other assessment methods. The footnotes for each table are an important part of the data.

## Collections and Access

Describing the dynamic nature of research library responsibilities, a report from the Association of Research Libraries observed that “developments in digital technology, the introduction of the Web and the Internet, and new methods of creating, sharing, and using knowledge have changed dramatically the traditionally understood definitions of library collections and access services. Building collections and creating access to them are no longer achieved just within the walls of the library. Broadly defined, collections and access responsibilities are no longer distinct spheres within research libraries.”<sup>2</sup> Unfortunately, research library statistics and report traditions tend to separate these “inextricably linked” activities.

Total investment for collections and access rose to \$225.2 million from \$207.6 million, an increase of 8.5% during a period when the Canadian Consumer Price Index rose about 3%. Expenditures for collections and access increased in 23 of the 29 member libraries. Institutional funding received from external sources and expenditures on behalf of institutions by external agencies were nearly 7% of the expenditures for collections and access.

Forty percent, the largest proportion, of collections and access expenditures was for print serial titles. At the same time, there was evidence of the transition to digital information. The amount spent for print serials continued to decrease, from \$97.7 million last year to \$89.6 million this year. Eight university libraries spent more on electronic serial titles than on print serial titles, whereas in

the previous year only one did so. Expenditures attributed to print monographs and electronic serials were each about one-fourth of the total expenditures for collections and access.

Again, total expenditures on print monographs increased from the previous year. Fewer institutions than last year increased expenditures for print monographs. Concordia, however, more than doubled these expenditures. Even as expenditures increased, the total number of print monographs purchased declined slightly from 617,015 to 608,333, ending several years of increases in monograph acquisitions. The variety among CARL member is evident in the number of volumes added at individual institutions: from 16,569 to 362,161 volumes with a median of 41,539 volumes added.

The ratio of "volumes withdrawn" to "volumes added" ranged from 0 to .93 of volumes and .20 was the median. That is, one library withdrew no volumes and another library withdrew .93 volume for each volume added. Information beyond *CARL Statistics* would be necessary to determine whether this difference in practice results from library culture and policy, from the availability of space, from the availability of staff, or for other reasons. The amount of shelving added by the reporting libraries is less than half the amount needed to shelf the net new volumes.

The steady and substantial increase in expenditure for and access to electronic serial titles was described above. McGill spent almost \$2.5 million on electronic monographs, more than all other institutions combined.

## Service Trends

Probably reflecting both the variety among CARL members and the turbulence of the transition to digital information, circulation activity again showed a mixed picture. Total circulation was stable; circulation (initial loans) increased in half the libraries and decreased in half. Interestingly, the range is from an increase of 15% to a decrease of 15%. In-house collection showed more consistent, and generally larger, percentage decreases. Overall, in-house use decreased 11%.

The average number of hours per week of reference service offered by CARL university libraries was 95.4, maintaining the gradual increase from 91.7 in 1999-2000. The median hours of service were 94 with a range from 138 to 75.

The total number of reference transactions decreased slightly. However, the general trend is down with decreases in 21 libraries. The decline was masked by a 19% increase representing 85,287 transactions reported by the University of Toronto. Twenty-eight libraries offered asynchronous reference service via e-mail up from 25 the previous year and 14 libraries offered synchronous reference service via Internet chat capability up from eight the previous year.

The total number of participants in library instruction presentations increased by 16.8%. Again, there was great variation among institutions with changes from -25.3% to 235.1%, but the general trend was up. These figures may represent new programs, new modes of delivery, and new demand or they may reflect altered methods of collecting and reporting data. Information about the outcomes for participants of these presentations must rely on other evaluation methods.

### *Document Delivery Services*

Document delivery policies, practices and activity levels in 2002-2003 were very similar to those in the previous year. Nationally, the number of items sent to other institutions was stable. However, the number of items sent by CISTI (755,746) is greater than the number sent by all other institutions combined. Thus, a continuing decline in the number sent by CISTI masked an increase in the number sent by university libraries.

In spite of the substantial increase in the availability of electronic journals, the number of copies of articles received by libraries has not decreased significantly. Among the possible causes of continuing demand for journal articles are: online indexes and abstracts that make resource discovery easier; document delivery contracts that make resource retrieval easier and at least a decade of journal cancellations,

There was a modest increase in the adoption of technology to support user access and library operations. There has not been an expansion of intra-institutional delivery services.

### *Data Services*

Information is less complete, and less standardized, for data services than for the older surveys. The number of physical files increased by 17% nationally. However, growth rates ranging from -49% to 627% at the 16 reporting libraries reporting may indicate revised counts as much as acquisitions and deaccessions. Unmediated access rose by 33% at the ten libraries which report this information. Like document delivery services, data services are extremely dependent on a sophisticated network of consortia and cooperative agreement to meet the needs of local researchers. Fostering these collaborative arrangements requires financial investment, technical knowledge and political wisdom—none of which are visible in the annual statistics.

## **Library Staffing**

The percentage of the library budget spent on salaries and wages remained stable as the absolute expenditure for salaries and wages increased by 5%. Some of the additional expenditure reflects a 2% increase in the number of library staff, the second year of modest staff growth. Professional staff grew more in both absolute and percentage terms than the other staff categories. Among professional staff, the number of administrative librarians and other professionals remained stable; the increase occurred among non-administrative librarians.

The growth of library staff was much more substantial in the national libraries than in university libraries. The number of staff in the two national libraries increased by 6% whereas the number of staff in the 27 university libraries increased by 1%. During the same period, university enrollment increased by 3%. The number of staff increased or remained the same in 22 of 29 member libraries.

The average years of experience of professional staff in university libraries continues to drop, but there is great variation among regions and institutions. For example, the average years of experience of professional staff in all regions except British Columbia is greater than the national average. In 20 of 27 institutions the change in average number of years experience was less than a

year, but in three institutions it was 3 or 4 years. In all three cases the number of professional staff increased or remained which is evidence that the change represents new hires of junior professional staff, not just the result of retirements and attrition.


Although the average years of experience dropped, the average professional salary in university libraries was \$68,748 in 2003-2004, up from \$65,592 the previous year. This is an increase of 4%. Ontario had the highest average salary, although the Atlantic region, Quebec, and the Prairie region had higher average years of experience. This is a change from the previous year. Carleton and York continue to report the highest average salaries, although the average salary at Carleton has dropped from \$85,235 to \$82,735. Three institutions report higher average years of experience than Carleton. Western continues to report the lowest average salary and the lowest average years of experience.

Salary distribution tables for professional librarians in university libraries continue to demonstrate the close link between years of experience and salary. Average salaries climb from \$49,293 for those with less than 7 years of professional experience to \$83,479 for those with over 35 years of professional experience. In 2003-2004, there were 316 librarians in university libraries earning more than \$80,000, up from 229 the year before.

## Expenditures

Total expenditures in Canadian research libraries increased by 5% over the previous year, about two percent above the CPI for that period. Twenty two of the twenty nine member libraries spent more than in the previous year. Considering the digital information revolution in research libraries, there has been a remarkable consistency in the proportion of expenditures on materials, staffing and operating budget lines in recent years.

Driven by more than a decade of rapid price increases for journal subscriptions, absolute expenditures on library materials have risen faster than the overall library expenditures. As a result, total expenditures on staffing and operating have risen more slowly than overall library expenditures. The leaders and staff in Canadian research libraries have demonstrated creativity and flexibility in their ability to participate in a digital information revolution largely through internal reallocation of library budgets.

Total expenditures in Canadian university libraries increased by just over 3% from the previous year and closely matched the increase in the student enrollment. There is a great variation in expenditure per student at Canadian university libraries, ranging from \$351 to \$1,256 with a median of \$535. No university collects a student access fee to help fund the library budget.

## Conclusion

In October 2004, *The Globe and Mail* published a University Report Card <http://www.theglobeandmail.com/generated/realtime/specialReportCard.html> that compiled the opinions of 27,811 undergraduates who were members of the studentawards.com online database. In almost every instance, CARL university libraries received grades of A+, A, A- and B+ from these students. Some of the foundation for these student opinions can be found in the input and output data of the *CARL Statistics* in earlier years.

# Statistiques de l'ABRC 2002-2003


## Tendances et observations

### Introduction

« Les héros authentiques de la révolution numérique dans l'enseignement supérieur sont les bibliothécaires; ce sont les personnes qui ont vu le plus loin, qui ont fait le plus, qui ont relevé les défis les plus redoutables et qui ont démontré le plus clairement les avantages de l'information numérique... Du fait que nous tenons pour acquises leurs réalisations, il s'agit d'un témoignage de leur succès. »<sup>1</sup> Cette déclaration récente par des cadres supérieurs universitaires est une observation perspicace. On trouve dans la publication annuelle *Statistiques de l'ABRC* des indicateurs de la révolution numérique dans les bibliothèques universitaires : expansion rapide de l'accès aux revues électroniques, accroissement des possibilités pour la livraison des documents, accès plus facile aux archives de données, nouveaux services.

L'élargissement de l'accès aux revues électroniques est la manifestation la plus spectaculaire de la révolution numérique dans les bibliothèques universitaires. Le nombre de titres de périodiques électroniques accessibles dans les bibliothèques membres a augmenté de 41 % par rapport à l'année précédente et a plus que doublé en deux ans.

Or cette augmentation ne révèle même pas à quel point les archives des revues en ligne sont maintenant disponibles et à quel point le nombre de liens a augmenté dans les index et les revues en ligne qui élargissent l'étendue et la commodité de l'accès aux revues électroniques. Les données relatives à l'utilisation sur le site Web du Réseau canadien de documentation pour la recherche ([www.researchknowledge.ca](http://www.researchknowledge.ca)) indiquent, preuves à l'appui, que l'utilisation accrue des ressources électroniques est une réalité, et non seulement une possibilité.

Dans les bibliothèques de recherche comme dans d'autres organisations, la planification et les résultats font partie d'une chaîne d'attentes – depuis les intrants jusqu'aux activités, aux extrants et aux résultats. Les *Statistiques de l'ABRC* contiennent des données sur les intrants, les activités et les extrants. Ces données nationales, recueillies depuis de nombreuses années, sont une source importante pour faire le suivi des bibliothèques de recherche au Canada, pour observer les tendances et pour recenser les points qui doivent être approfondis. D'autres méthodes et ressources sont nécessaires pour mettre en lumière les retombées des collections et des services des bibliothèques de recherche et des ententes de collaboration qui sont en voie de constituer une ressource nationale efficace.

Les lecteurs attentifs des *Statistiques de l'ABRC* doivent savoir que, malgré l'attention apportée aux corrections et à la clarté, les données présentent des limites. Les définitions peuvent varier, soit au fil du temps, soit selon l'interprétation de chaque établissement. La fiabilité et l'exactitude de la collecte des données et des méthodes de présentation de l'information peuvent ne pas être uniformes. Chaque année, il y a des éléments de données qui ne sont pas déclarés par toutes les bibliothèques. Par conséquent, les conclusions ou les comparaisons – que ce soit entre les établissements ou sur une certaine période – doivent être faites avec précaution, compte tenu du contexte, et de préférence conjointement avec d'autres méthodes d'évaluation. Les notes qui accompagnent chaque tableau sont un aspect important des données.

## Collections et accès

À propos du dynamisme des responsabilités des bibliothèques de recherche, un rapport de l'Association of Research Libraries faisait observer que « l'évolution des technologies numériques, l'avènement du Web et de l'Internet, et les nouvelles méthodes de création, de partage et d'utilisation des connaissances ont transformé radicalement les définitions traditionnelles des collections des bibliothèques et des services d'accès. Le rassemblement de collections et les moyens d'y donner accès ne sont plus des tâches qui se font tout simplement à l'intérieur des murs de la bibliothèque. De façon générale, les collections et les responsabilités en matière d'accès ne sont plus des sphères distinctes dans les bibliothèques de recherche. »<sup>2</sup> Malheureusement, les statistiques sur les bibliothèques de recherche et les traditions en matière de présentation de l'information établissent généralement une distinction entre ces activités « inextricablement liées ».

Les fonds consacrés aux collections et à l'accès sont passés de 207,6 millions à 225,2 millions de dollars, soit une augmentation de 8,5 % pendant une période où l'Indice des prix à la consommation au Canada progressait d'environ 3 %. Les dépenses pour les collections et l'accès ont augmenté

dans 23 des 29 bibliothèques membres. Les fonds que les établissements ont reçu de sources extérieures et les dépenses qui ont été faites par des organismes extérieurs pour le compte des établissements se sont élevés à près de 7 % des dépenses pour les collections et l'accès.

Quarante pour cent, soit la plus forte proportion, des dépenses pour les collections et l'accès ont été consacrées aux titres de périodiques imprimés. Parallèlement, la transition vers l'information numérique poursuivait manifestement son cours. Le montant consacré aux périodiques imprimés a continué de baisser, soit de 97,7 millions l'an dernier à 89,6 millions de dollars cette année. Huit bibliothèques universitaires ont consacré plus d'argent aux périodiques sous forme électronique qu'aux périodiques sous forme imprimée, alors que, l'année précédente, c'était le cas d'une seule. Les dépenses consacrées aux monographies sous forme imprimée et aux périodiques sous forme électronique se sont élevées dans chaque cas à environ un quart du total des dépenses pour les collections et l'accès.

Encore une fois, les dépenses totales pour les monographies imprimées ont augmenté par rapport à l'année précédente. Moins d'établissements que l'an dernier ont augmenté leurs dépenses pour les monographies imprimées. Concordia toutefois les a plus que doublées. Même si les dépenses ont augmenté, le nombre total de monographies imprimées achetées a diminué légèrement de 617 015 à 608 333, ce qui mettait un terme à plusieurs années d'augmentation dans les acquisitions de monographies. La diversité parmi les membres de l'ABRC se manifeste dans le nombre de volumes acquis par chacun des établissements : de 16 569 à 362 161 volumes avec une médiane de 41 539 volumes.

Le ratio des « volumes retirés » et des « volumes ajoutés » s'échelonnait de 0 à 0,93 des volumes et la médiane était de 0,20. C'est donc qu'une bibliothèque n'a retiré aucun volume tandis qu'une autre en a retiré 0,93 pour chaque volume ajouté. Des données au-delà des *Statistiques de l'ABRC* seraient nécessaires pour déterminer si cette différence est attribuable concrètement à la culture et à la politique de la bibliothèque, à l'espace disponible, au personnel disponible ou à d'autres motifs. La quantité de rayons ajoutés par les bibliothèques déclarantes est inférieure à la moitié de ce qui est nécessaire pour ranger le nombre net de nouveaux volumes.

L'augmentation constante et remarquable des dépenses pour les titres de périodiques électroniques et l'accès à ces périodiques a été décrite ci-dessus. McGill a consacré près de 2,5 million de dollars aux monographies électroniques, plus que tous les autres établissements ensemble.

## Tendances des services

Étant donné probablement la diversité des membres de l'ABRC et les fortes perturbations causées par la transition vers l'information numérique, la circulation a présenté encore une fois un tableau varié. La circulation totale a été stable; la circulation (prêts initiaux) a augmenté dans la moitié des bibliothèques et a diminué dans l'autre moitié. Fait intéressant, la fourchette s'échelonne d'une augmentation de 15 % à une diminution de 15 %. Le pourcentage de diminution pour les collections internes a été plus uniforme et généralement plus élevé. Dans l'ensemble, l'utilisation interne a diminué de 11 %.

Le nombre moyen d'heures par semaine de services de référence offerts par les bibliothèques universitaires de l'ABRC a été de 95,4, dans la foulée de la hausse progressive à partir de 91,7 en 1999-2000. Le nombre médian d'heures de services a été de 94 avec une fourchette de 138 à 75.

Le nombre total de questions de référence a fléchi légèrement. Toutefois, la tendance générale est à la baisse puisqu'il y a eu une diminution dans 21 bibliothèques. La baisse a été dissimulée par une hausse de 19 % représentant 85 287 questions déclarées par l'Université de Toronto. Vingt-huit bibliothèques ont offert un service de référence en mode asynchrone par courrier électronique, par rapport à 25 l'année précédente, et 14 bibliothèques ont offert un service de référence en mode synchrone par clavardage sur Internet, par rapport à huit l'année précédente.

Le nombre total de participants aux présentations sur les services documentaires a augmenté de 16,8 %. Encore une fois, il y avait de grandes différences entre les établissements puisque l'écart s'échelonnait de - 25,3 % à 235,1 %, mais la tendance générale était à la hausse. Ces chiffres peuvent s'expliquer par de nouveaux programmes, de nouveaux modes de présentation et une nouvelle demande, ou encore par des méthodes différentes de collecte et de présentation des données. Pour obtenir des données sur les résultats de ces exposés pour les participants, il faut utiliser d'autres méthodes d'évaluation.

## **Services de livraison de documents**

Les politiques, les pratiques et l'activité pour la livraison des documents en 2002-2003 ont été très semblables à ce qui s'est passé l'année précédente. À l'échelle nationale, le nombre de documents envoyés à d'autres établissements a été stable. Toutefois, le nombre de documents envoyés par l'ICIST (755 746) est plus élevé que le nombre envoyé par tous les autres établissements ensemble. Par conséquent, la baisse constante du nombre de documents envoyés par l'ICIST a dissimulé l'augmentation du nombre de documents envoyés par les bibliothèques universitaires.

Malgré la forte augmentation de la disponibilité des revues électroniques, le nombre de copies d'articles reçus par les bibliothèques n'a pas beaucoup diminué. Parmi les causes possibles de la demande constante d'articles de revues, mentionnons les index et les résumés en ligne, qui facilitent la découverte des ressources, les contrats de livraison de documents qui facilitent la récupération des ressources, et l'annulation des abonnements aux revues depuis au moins une décennie. Il y a eu une modeste croissance de l'adoption de technologies pour faciliter l'accès par les utilisateurs et les tâches des bibliothèques. Il n'y a pas eu d'augmentations des services de livraison de documents à l'intérieur des établissements.

## **Services de données**

L'information est moins complète, et moins uniforme, pour les services de données que dans les enquêtes antérieures. Le nombre de dossiers physiques a augmenté de 17 % à l'échelle nationale. Toutefois, étant donné les taux de croissance qui s'échelonnent de - 49 % à 627 % pour les 16 bibliothèques déclarantes, il pourrait s'agir autant de dénombrements révisés que d'acquisitions et de retraits d'inventaire. Les services sans intermédiaire ont augmenté de 33 % dans les dix bibliothèques qui font état de cette donnée. Tout comme les services de livraison de documents, les services de données dépendent beaucoup d'un réseau complexe de

consortiums et d'ententes coopératives pour répondre aux besoins des chercheurs locaux. Pour favoriser ces ententes de collaboration, il faut des investissements financiers, des connaissances techniques et une sagesse politique – et aucun de ces éléments n'est visible dans les statistiques annuelles.

## Personnel des bibliothèques

Le pourcentage du budget des bibliothèques consacré aux salaires est resté stable tandis que la dépense absolue pour les salaires a augmenté de 5 %. Une partie des dépenses est attribuable à l'augmentation de 2 % du personnel des bibliothèques, soit la deuxième année d'une croissance modeste. Le personnel professionnel a augmenté davantage tant en nombre absolu qu'en pourcentage par rapport à toutes les autres catégories de personnel. Parmi le personnel professionnel, le nombre de bibliothécaires administratifs et des autres professionnels est resté stable; la hausse s'est produite parmi les bibliothécaires non administratifs.

La croissance du personnel des bibliothèques a été beaucoup plus marquée dans les bibliothèques nationales que dans les bibliothèques universitaires. Le nombre d'employés dans les deux bibliothèques nationales a augmenté de 6 %, tandis qu'il n'a augmenté que de 1 % dans les 27 bibliothèques universitaires. Au cours de la même période, l'effectif universitaire a augmenté de 3 %. Le nombre d'employés a augmenté ou est resté le même dans 22 des 29 bibliothèques membres.

Le nombre moyen d'années d'expérience du personnel professionnel dans les bibliothèques universitaires a continué de baisser, mais il y a une forte variation entre les régions et les établissements. Par exemple, le nombre moyen d'années d'expérience du personnel professionnel dans toutes les régions sauf en Colombie-Britannique est plus élevé que la moyenne nationale. Dans 20 des 27 établissements, la variation du nombre moyen d'années d'expérience a été de moins d'un an, mais, dans trois établissements, elle a été de trois ou quatre ans. Dans les trois cas, le personnel professionnel a augmenté ou est resté le même, ce qui montre que la variation correspond au nombre de nouveaux employés professionnels débutants embauchés, et n'est pas seulement le résultat des départs à la retraite et de l'attrition.

Bien que le nombre moyen d'années d'expérience ait diminué, le salaire moyen des professionnels dans les bibliothèques universitaires était de 68 748 \$ en 2003-2004, par rapport à 65 592 \$ l'année précédente, soit une hausse de 4 %. C'est en Ontario que le salaire moyen était le plus élevé, mais c'est dans la région Atlantique, au Québec et dans la région des Prairies que le nombre moyen d'années d'expérience était le plus élevé. Il s'agit là d'un changement par rapport à l'année précédente. Carleton et York ont encore une fois déclaré les salaires moyens les plus élevés, bien que le salaire moyen à Carleton ait diminué de 85 235 \$ à 82 735 \$. Trois établissements ont déclaré un nombre moyen plus élevé d'années d'expérience que Carleton. C'est à Western que le salaire moyen est encore le plus bas, de même que le nombre moyen d'années d'expérience.


Les tableaux de distribution des salaires pour les bibliothécaires professionnels dans les bibliothèques universitaires montrent encore le lien étroit entre les années d'expérience et le salaire. Les salaires moyens passent de 49 293 \$ pour ceux qui ont moins de sept années d'expérience professionnelle à 83 479 \$ pour ceux qui en ont plus de 35. En 2003-2004, il y avait

316 bibliothécaires dans les bibliothèques universitaires qui gagnaient plus de 80 000 \$, par rapport à 229 l'année précédente.

## Dépenses

Les dépenses totales dans les bibliothèques de recherche au Canada ont augmenté de 5 % par rapport à l'année précédente, soit environ 2 % de plus que l'IPC pour cette période. Vingt-deux des 29 bibliothèques membres ont dépensé plus que l'année précédente. Compte tenu de la révolution de l'information numérique dans les bibliothèques de recherche, il y a eu une constance remarquable dans la proportion des dépenses pour le matériel, le personnel et le budget de fonctionnement depuis quelques années.

Propulsées par l'augmentation rapide des prix pour les abonnements aux revues depuis plus d'une décennie, les dépenses absolues pour les documents ont augmenté plus rapidement que l'ensemble des dépenses des bibliothèques. C'est ainsi que les dépenses totales pour le personnel et le fonctionnement ont augmenté plus lentement que l'ensemble des dépenses des bibliothèques. Les chefs de file et les employés des bibliothèques de recherche au Canada ont fait preuve de créativité et de souplesse dans leur capacité de participer à la révolution de l'information numérique par une nouvelle répartition interne des budgets des bibliothèques.

Les dépenses totales dans les bibliothèques universitaires du Canada ont augmenté d'un peu plus de 3 % par rapport à l'année précédente et ont suivi étroitement l'augmentation de l'effectif étudiant. Il y a une forte variation des dépenses par étudiant dans les bibliothèques universitaires du Canada, soit de 351 \$ à 1 256 \$, avec une médiane de 535 \$. Aucune université ne perçoit de droits d'accès auprès des étudiants pour financer le budget de ses bibliothèques.

## Conclusion

En octobre 2004, *The Globe and Mail* a publié un « Bulletin des universités » <http://www.theglobeandmail.com/generated/realtime/specialReportCard.html> qui recueillait les opinions de 27 811 étudiants de premier cycle qui étaient membres de la base de données en ligne studentawards.com. Dans presque tous les cas, les étudiants ont attribué aux bibliothèques universitaires de l'ABRC les notes A+, A, A- et B+. Ces résultats s'expliquent en partie par les données sur les intrants et les extrants des *Statistiques de l'ABRC* dans les années précédentes.




