
Annual Report 2022

believe in, such as NIKLA's work on respectful description; our expansion of scope to include Teaching and Learning; and our deepening engagement with local library workforces and international arenas, both areas through which we share our wisdom and learn from others.

I would like to thank our members, committee chairs, board, staff, and stakeholders for their continued commitment to the initiatives listed in this report. It is thanks to their vision, leadership, and enthusiasm, that the accomplishments reflected in this report are possible.

Executive Director's Message

In 2022 CARL welcomed a new Senior Program Officer and Project Director for National Shared Repository Infrastructure, as well as three new Visiting Program Officers in the areas of copyright and equity, diversity, and inclusion.

CARL issued a number of responses to national issues and published the final Insights Report from its Diversity and Inclusion Study, prepared by the Canadian Centre for Diversity and Inclusion. In collaboration with ARL, CARL also commissioned Ithaka S+R to prepare a report on Aligning the Research Library to Organizational Strategy. As a follow-up to Ithaka's report, ARL Executive Director Mary Lee Kennedy and I began a series of STEM-focused site visits at Canadian and US institutions.



It has been a privilege to continue to work closely with library leaders throughout Canada on these and all the other initiatives described throughout this report.

Committee Highlights from 2022

In 2022 CARL made significant progress in advancing its strategic directions for 2019-2022 and 2022-2025. Key achievements and activities from the four CARL committees are described in the following pages.

Policy Committee

The Canadian political landscape experienced a number of changes in 2022 that had implications for CARL's advocacy efforts in 2022 and moving forward in 2023. Some Government of Canada announcements included plans and funding for initiatives that CARL has been advocating for: to support a national infrastructure for open educational resources; to increase funding to Library and Archives Canada to support the digitization of the federal Indian Day School System records; to provide additional investment in the Universal Broadband Fund; and to furnish additional funding for the Centre for Equitable Library Access (CELA) and the National Network for Equitable Library Service (NNELS). Toward the end of the year, the Government announced that the extension of the term of copyright to life of the creator plus seventy years would come into force on December 30, 2022 with no mitigating measures. CARL maintained a watching brief as federal government committees and the Senate actively engaged with:

- Bill C-27 An Act to enact the Consumer Privacy Protection Act, the Personal Information and Data Protection Tribunal Act and the Artificial Intelligence and Data Act and to make consequential and related amendments to other Acts (referred to as the Digital Charter Implementation Act, 2022);
- Bill C-11 An Act to amend the Broadcasting Act and to make related and consequential amendments to other Acts (referred to as the Online Streaming Act);
- Bill C-244 An Act to amend the Copyright Act (diagnosis, maintenance and repair); and,
- An unsuccessful attempt to design the legislative and regulatory framework to address harmful content online.

- In support of February's Fair Dealing Week, CARL updated the Fair Dealing Canada website with planned activities at member campuses across the country. Later in the year, a coalition of post-secondary education groups, including CARL, worked to develop a framework for a coordinated post-secondary educational fair dealing advocacy campaign in 2023.
- The joint ARL/CARL Marrakesh Treaty Implementation Task Force and Working Groups continued its work throughout 2022, leading to proposed changes to accessibility metadata standards.
- With the Canadian Federation of Library Associations (CFLA), we published "Controlled Digital Lending of Library Books in Canada" in the *Partnership* in December 2022.
- CARL considered its position, submitted briefs, or issued statements to provincial and federal governments on a number of issues of importance to libraries and higher education:
 - Federal Government's Cross-Canada Official Languages
 Consultations
 - CCPERB Guide to Monetary Appraisals
 - The second round of 2022 Budget Consultations
 - 2023 Pre-Budget Consultation.
- Represented by Susan Haigh, CARL participated in the National Cultural Summit: The future of arts culture and heritage in Canada that spanned two and half days in May 2022.

Strengthening Capacity Committee

Under the leadership of Melissa Just (Saskatchewan), the Strengthening Capacity Committee (SCC) worked toward the long-term support of librarian research, workforce development and renewal, strategic recruitment, leadership and management development, and equity, diversity, and inclusion. SCC's 2022 initiatives included:

- CARL held its inaugural Academic Librarians' Leadership Institute (ALLI)
 at Memorial University from June 6-12. The institute was developed by the
 Gardiner Centre, the engagement arm of the Faculty of Business
 Administration, Memorial University, with input from CARL directors and
 associate-level academic Librarians.
- A number of professional development opportunities for CARL member library directors were initiated.
- In September, Susan Cleyle's appointment as CARL Visiting Program
 Officer for Leadership Development Initiatives was renewed for an
 additional 1-year term, and she continued to engage with SCC's growing
 slate of leadership development initiatives.
- Under the leadership of Lisa O'Hara (Saskatchewan), and Victoria Ho, CARL Visiting Program Officer for Equity Diversity and Inclusion, the EDI Working Group continued its series of inclusion perspectives webinars with a fourth panel featuring library colleagues with disabilities.
- The final report on CARL's national diversity and inclusion study of participating member libraries was published in May.
- The 2022 cycle of CARL's Research in Librarianship Grant was administered (see recipients of the practicing librarian category on page 15).
- Following the postponement of the 2020 Librarians' Research Institute (LRI) due to the COVID-19 pandemic, in 2022 CARL began planning for an English-language LRI to take place in June 2023 and a Frenchlanguage LRI to take place in late spring of 2024.

Advancing Research Committee

Under the leadership of Talia Chung (Ottawa), the Advancing Research Committee (ARC) continued to further the goals set out in CARL's Strategic Directions.

- The Open Repositories Working Group, led by Andrea Kosavic (York) and Dany Bouchard (UQAM) concluded its work in December 2022. The group's Community Building and Engagement Task Force hosted a well attended webinar in June 2022, "Canadian DSpace User Group Presents: So It's Time to Upgrade DSpace."
- The CARL OpenAIRE Task Group, under the leadership of Pierre Lasou (Laval), completed the pilot implementation phase of the CARL OpenAIRE collaboration and issued a report in April 2022. A plan for expanding the CARL-OpenAIRE collaboration beyond pilot institutions and for its sustainable management was approved in October.
- The Open Education Working Group, chaired by Joy Kirchner (York) and with Ann Ludbrook (TMU) as continuing Visiting Program Officer, refreshed its membership and mandate in July 2022. Four new task groups were established:
 - Indigenous Communities and OER
 - Sous-groupe de travail sur l'éducation ouverte francophone
 - Surveys and OE Data Collection
 - Community of Practice & Outreach.
- An Open Educational Resources (OER) National Strategy group was
 formed to engage with stakeholders including national student groups,
 representatives from provincial open education organizations, scholars
 and advocates. Work was initiated on the National Advocacy Framework
 for Open Educational Resources in Canada. In November, the first of
 three planned national meetings took place. The National Summit for OER
 Policy and Infrastructure Summit was hosted by York University and
 brought together over 30 participants from different stakeholder groups.

- A shared repository infrastructure initiative was commenced with G.
 Harder assuming a one-year FT appointment as Project Lead, Shared
 Repository Infrastructure in September.
- Plans to create a BRI Community of Practice Steering Committee were initiated.
- Gwen Bird (SFU) continues to represent CARL on North: The Canadian Shared Print Network. CARL invests \$5000 annually to this initiative.
- Catherine Steeves (Western) became the CARL representative on the board of SPARC.
- CARL's partnership with CRKN for Canadian contributions to SCOSS continued with the announcement of three new infrastructures endorsed by SCOSS (ArXiv, Redalyc/AmeliCA, and DSpace).

Assessment Committee

Under the leadership of Mary-Jo Romaniuk (Calgary), CARL continued to support assessment within and across Canadian research libraries by collecting and publishing data that demonstrates the valuable contributions of these libraries toward higher education and the research enterprise, and by facilitating the continued evolution of library services. 2022 initiatives included:

- CARL's Continuing Education Working Group continued to plan webinars as part of its on-going series in lieu of an in person CLAW 2021 (canceled as a result of the COVID-19 pandemic). This included a webinar on user experience and assessment held on January 12th, 2022. In the fall of 2022, planning for an in-person CLAW 2023 began.
- Following the publication of CARL's Library Impact Framework in December 2021, the Library Impact Framework Working Group, under the leadership of Mark Robertson (Brock), shifted their focus to promoting the resource, including via a webinar on February 15.
- Work entered the second phase of development on the backend of the CARL statistics collection tool to enhance users' experience for entering and manipulating data in future years.



Continuing Special CARL Activities to Support Institutions

CARL continued to facilitate bi-weekly informal Zoom sessions where CARL directors could come together to informally discuss top-of-mind issues and update each other on practices and changes at their establishments.

CARL continued its series of regular webinars and community calls on topics of interest to the various library communities of practice that they support, that were free and open to all – both CARL members and non-members. The Spring General Meeting was held April 25-28, 2022 in Toronto. As it was organized jointly with ARL and was the first in-person meeting since the beginning of the COVID-19 pandemic, it provided an excellent opportunity for attendees to network, and to engage on topics related to leadership and international collaboration during a time of significant transformations.

The CARL Fall Meeting took place on November 15-17, 2022 in Ottawa and included program sessions on Open Science Strategy, digital preservation and the Digital Research Alliance of Canada, as well as mental wellness in the workplace and expanding the library's role in supporting teaching and learning. The last day was devoted to advocacy meetings on the Hill.
